SECTION 8. DUTIES OF PERMITTEE: (1) A permittee hereunder shall comply with all permit directions and conditions and with all applicable laws and ordinances. (2) The chairperson or other person heading or leading such marathon shall carry the permit upon his person during the conduct of the marathon and shall display said permit upon request by proper offices, agents or employees of the city. (3) The chairperson or other person shall monitor the marathon and make himself available at all times during the marathon to the Chief of Police or his designated representative. (4) It shall be unlawful for any person in charge or responsible for the conduct of a duly licensed marathon knowingly to fail to comply with any condition of the permit.
